

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.mosswoodlarp.com, and Badger & Bobcat, LLP and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Badger & Bobcat, LLP include www.mosswoodlarp.com, Badger & Bobcat and Mosswood. The Badger & Bobcat website is a game subscription site. By using the Badger & Bobcat website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Badger & Bobcat may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase Badger & Bobcat's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
